In this organization women's median hourly wages are 2% more than men's. For every dollar men earn in median hourly wages, women earn \$1.02 in median hourly wages. *

Explanatory notes

2. "Median hourly pay gap" refers to the differences in pay between gender groups calculated by the mid range of pay for each group. Hourly pay does not include bonuses and overtime.

In this organization women's average overtime pay is 21% less than men's. For every dollar men earn in average overtime pay, women earn 79 cents in average overtime pay. *

In this organization women's median overtime pay is 31% more than men's. For every dollar men earn in median overtime pay, women earn \$1.31 in median overtime pay. *

The self - identified gender data that has been collected for this report has been heavily weighted to "Unknown/Prefer not to disclose", due to 85% of the total workforce reported choosing either to not disclose their self-identified gender identity, or by not selecting their choice by the requested deadline.

7. "Mean bonus pay" refers to bonus pay when averaged for each group.
8. "Median bonus pay" refers to the middle point of bonus pay for each group.
9. "Pay quartile" refers to the percentage of each gender within four equal sized groups based on their hourly pay.
