Role Summary

As a Children's Life Skills Worker, you provide support and teach independence to children by creating engaging, meaningful, and individualized learning experiences in their homes and communities.

You assess each child's unique strengths, interests, and learning needs, and work with them to set achievable goals.

You develop and implement person-centred programs that are tailored to each child, making learning fun, relevant, and motivating.

You continuously evaluate and adapt these programs to ensure they meet the child's evolving needs, helping them build confidence, independence, and skills to thrive in everyday life.

Responsibilities

- Advocate for and assist children to recognize and exercise their rights, supporting self-confidence and empowerment.
- Develop, maintain, and update Essential Lifestyle Plans in cooperation with children, their families, and MCFD.
- Be a positive role model and provide emotional support and feedback to children and their families, promoting the development of social skills.
- Act as a liaison with other agencies involved in the child's life to ensure coordinated and consistent support.
- Recognize potential crisis situations, analyze them accurately, develop strategies to address them, and inform the program manager as required.
- Facilitate integrated community-based skills, including physical, recreational, social, educational, and vocational activities.
- Teach basic life skills and promote the development of social networks, including connections with other service providers.
- Accurately maintain all necessary program reports and data, completing daily and quarterly progress reports.
- Build rapport through open communication and positive interaction with children's families and caregivers.
- Attend employee meetings, workshops, and training sessions to enhance professional skills and program quality.
- Perform other related duties as required to ensure meaningful, safe, and high-quality experiences for children.
